As per the reference 3rd cited and as per statutes on affiliation of Homoeopathic Medical Colleges, Dr.NTR University of Health Sciences, Vijayawada, it is hereby certified that the application of KKC Homoeopathi Medical College, Parameswara Mangalam, Puttur Chittoor District,, sponsored by Kakumani Educational Society, Puttur, for running of BHMS Course has been registered with Dr.NTR University of Health Sciences, Vijayawada and Conditional Affiliation is granting for starting of 2nd Year BHMS and for admitting students with an intake of 100 seats (Hundred seats) for the Academic Year 2020-21, subject to fulfillment of the deficiencies specified by the CCH,/ Ministry of AYUSH, Government of India, New Delhi / Govt. of A.P. / Dr.NTR UHS, Vijayawada from time to time.

The number of students admitted should not exceed the number of students permitted for Annual Admissions both under University and Management Quota as specified by the State Government / Dr. NTR University of Health Sciences, Vijayawada.

The fee collected by whatsoever name called either for university seats or for Management seats shall not exceed the limits specified by the State Government /Dr.NTR University of Health Sciences from time to time.

The college has to comply with the full requirements of HCC (MSR) Regulations, 2013 by 31st December, 2020 for continuing admissions during the subsequent year. A copy of compliance report shall be submitted by the college to CCH under intimation to the Ministry. Subsequently, CCH shall verify the compliance well in time for considering the admissions during the Academic year 2021-22 and furnish the recommendation to the Central Government.

The Management of the college shall follow the regulations made by the University / State Government / Ministry of AYUSH, Government of India in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation in this regard may lead to withdrawal of affiliation to the college without any notice.

This order is valid for a period of one year from the date of issue and subject to the permission of Central Council of Homoeopathy / Department of AYUSH, Government of India, New Delhi from time to time.
