Application for Letter of permission for KKC Homoeopathic Medical College, 1-52, KKC Nagar, Prameswara Mangalam, Puttur-517584, Andhra Pradesh for conducting BHMS course with student intake of 100 seats in UG (BHMS) course for the academic vear 2023-24 - reg.

Sir,

KKC Homoeopathic Medical College, Andhra Pradesh is functional since 2019 and has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 23-24, in which the entire functional profile has been narrated. The application has been examined by Medical Assessment and Rating Board for Homoeopathy as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020 and conducted the Inspection of college on 17.07.2023 and 18.07.2023. Accordingly, it is to inform you that inspection reports submitted by inspectors, were examined by the Medical Assessment and Rating Board and following deficiencies were noticed:

- 1. College is situated along with other institutions of KKC group.
- 2. There is a building of 04 floor, half of which is for proposed Ayurveda college and half for Homoeopathy college.
- 3. Reception and hospital registration was in one counter at the entrance with manual registration.
- 4. No. of patients in OPD/IPD shown does not match with no. of patients attended OPD/IPD during visit and seems to be exaggerated, fabricated with many discrepancies, such as: During visit at 10 am, no patient was seen in OPD and IPD. After sometime, 02 male and 04 female patients seen in IPD beds, which stated that they are admitted 2-3 days back.
- 5. IPD records are not properly filled and without any signature of concerned doctors.
- 6. IPD medicine dispensing records are not matching with central OPD and IPD records.
- 7. Computerized central registration system, central IPD, proper filling of OPD/IPD case records are not evident.

- 8. Most of OPD IPD case records information captured is incomplete.
- 9. OPD and IPD case records are without doctor's signature.
- 10. IPD follow ups are without doctor's signature. Investigation reports are without clinician's signature.
- 11. IPD Bed occupancy and average no. of patient's in OPD is not as per the norms.
- 12. Dr. C Nagalakshmi (Gynecologist), Dr B. Mallikarjun (Pathologist) and Dr. K. Sridhar (General Surgeon) was found absent during visit (18.07.2023) but had signature on attendance register. On enquiry, principal could not justify their absence.
- 13. Signature of A. Sadasivam (Dark room attendant) and P Krishnamoorthy (Storekeeper) was not found matching with signature with their acquittance & attendance, when they signed in front of visitors, as if someone is signing their signature.
- 14. No paediatric beds in IPD.
- 15. Duty doctors were not seen in OPD and IPD as per the rosters.
- 16. No guest faculty and modern medicine doctors seen during inspection, despite of their scheduled class on 17-18th July 2023.
- 17. No online payment of modern medicine and guest faculties but through voucher only.
- 18. All departments are having single rooms which includes lab, museum, and demonstration which are not sufficient for 100 UG intake.
- 19. Modern medicines and guest faculties are not coming regularly.
- 20. College is not covered under Anatomy Act.
- 21. College is not contributing for PF/EPF mandatorily for all employees except 07 non-teaching & hospital staffs whose salary are below Rs. 15000.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis of all cases should be written in ICD 11 criteria

Considering the above observations, and facilities available, Medical Assessment and Rating Board for Homoeopathy has decided to issue conditional permission to KKC Homoeopathic Medical College, 1-52, KKC Nagar, Prameswara Mangalam, Puttur-517584, Andhra Pradesh for conducting BHMS course for admitting 60 seats (reduced from 100 seats) for the academic year 2023- 24. The shortfalls observed in your College shall be rectified within a period of 15 days and compliance report shall be submitted to the MARBH failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling

Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.

If the College is aggrieved with the above decision, College may place an appeal to the National Commission for Homoeopathy as per NCH Act 2020 section 24 sub-section (3) within a period of 30 days.
