Decision/Order of the Commission

आयोग का निर्णय /आदेश

Appeal under section 24 of the National Commission for Homoeopathy Act 2020, submitted by Principal, KKC Homoeopathic Medical College & Hospital, vide letter no. 418/KKCH/NCH Inspection-Appeal dated 15.07.2024.

Appeal vide letter no. 418/KKCH/NCH Inspection-Appeal dated 15.07.2024 from KKC Homoeopathic Medical College & Hospital has been received by the Commission under section 24 of NCH Act 2020 against the decision of Medical Assessment and Rating Board for Homoeopathy.

The MARBH conducted inspection on 06.06.24 & 07.06.24 following which MARBH vide letter no. 4-7/2024-25/NCH(MARBH)(102-07)/2098 Dated 02.07.2024 decided to issue permission for continuation of permission in Ist BHMS course with reduced intake capacity from 100 seats to 50 seats, for the academic session 2024-25.

The Commission upon examination of the documents submitted by the college with the appeal, has made the following observations:

I. Observation of Commission:

Pointwise observation on submission:

Teaching faculties:

1. From the submitted manual attendance register it shows presence of 02 consultants of Modern Medicine and having signature of visiting team.
2. Now, as per MSR regulations 2013, Consultants of Modern Medicine can be called on-call basis and it is not mandatory to call them on regular basis.
Thus, submission is acceptable.

Hospital details:

1. It is observed that college has provided 05 leave letters and appointment & joining of Assistant dresser. Thus, leave letters are acceptable.
It is observed from the College bank statement that the college has credited a consolidated amount for salary disbursement.
2. As per MSR Regulation 2013 Teachers in the Departments of Surgery, Obstetrics and Gynecology, Pathology, Biochemistry can be deputed as Surgeon, Obstetrician/Gynecologist, Pathologist and Biochemist respectively amongst the hospital staff. Thus, submission is acceptable.

3. It is observed that the USG machine was not in working condition and service was conducted which is verified form service invoice. Thus, submission is acceptable.
4. As per MSR Regulation 2013 there is no specific OT nursing staff required for the hospital. However, college has provided nursing duty roster and on random verification from the attendance register and duty roster it is found correlating. Thus, submission is acceptable.
5. It is observed that the college purchased autoclave machine in the year 2017 but the college failed to provide any document for fumigation such as fumigation register. Thus, submission cannot be accepted.
6. It is observed that the OPD case records complete, however, needs improvement as it has no heading related to LSMC, Physical & Mental general, diagnosis, analysis, advice and management.
It is also observed that the x-ray register, lab register, medicine dispensing register, departmental register and diet register are not signed by x-ray technician, lab technician, Pharmacist, consulting physician and dietician for its authenticity. Although the records are maintained but need improvement. Thus, submission is acceptable.
7. It is observed from the submitted OPD/ IPD case records that the cases have systemic examination recorded. Thus, submission is acceptable.
8. It is observed that consulting physician name in OPD and IPD is not available in the case record. Thus, submission cannot be accepted.
9. It is observed that report of the X-Ray, ECG and USG findings are not documented in respective OPD case records however, it can be documented in the next follow up visit. Thus, submission cannot be accepted.
10. It is observed that MoU between Subhashini Multispecialty Hospital and the college is in order and is acceptable.
11. It is observed that signature of the Nurse is available on nurses notes however, name of the nurse is not available. Submission is acceptable.
12. The college has submitted that some of the IPD case records are written by 4th year students and is acceptable as the college is not having intern students. However, the prescription is signed by Medical officer.
13. Clinical evaluation in IPD cases is not available however, such improvements in the hospital must be considered.
14. The available case records have repertorial sheets annexed with the IPD case records.
15. As per MSR regulation 2013 the General surgeon, Gynecologist and Pathologist can be from the teaching staff. Thus, submission is acceptable.

Hospital Infrastructure:

1. The college has provided only the map of Homoeopathic college thus, the remarks of MARBH cannot be verified.
2. The submission cannot be verified in absence of map of Physiotherapy college.
3. The map submitted has no demarcation in sq.mt. of each room thus, the submission cannot be verified.
4. As per MSR Regulation 2013 for Surgery and General Medicine wards are required as Male and Female. Thus, only two wards can be constructed with demarcation beds for Surgery and General Medicine. Thus, submission is acceptable.

5. As per the available map there is no designated Committee Room and College Record Room. Thus, submission is not acceptable.
6. As per the available map there is no designated room for Accounts office, administration. Thus, submission is not acceptable.

Miscellaneous:

It is observed that at present the college is not having Aadhar Enabled Biometric Attendance system and has made temporary registration.

Overall observation:

- A. It is observed that the college is having compliance as per MSR Regulation 2013 with regard to Hospital functionality. However, it needs improvement in terms of OPD case records of investigations and diet given to the patients.
 - B. It is also observed that the college is having minor deficiencies in terms of infrastructure for which the college may undergo certain modification in the hospital & college building.
 - C. It is also observed that the college is not having AEBAS for staffs.
 - D. Based on the submission made by KKC Homoeopathic Medical College on 15.07.2024 the documents have been carefully examined as per the provisions of the MSR, Regulations 2013 and the relevant provisions made there under and it is observed that the college does comply the provisions of MSR Regulations 2013, in terms of Hospital functionalities but needs to improve further and the college needs to undergo minor infrastructure changes and need to implement AEBAS.
 - E. Now, THEREFORE, the Commission decided to permit the college with the intake capacity of 100 seats for 1st BHMS course and directs the MARBH to issue permission order with revised intake capacity for the session 2024-25.
- II. Accordingly, your representation dated 15.07.2024 to Commission against MARBH letter dated 02.07.2024 stands disposed off.
